

The Greatest Reset Is Coming

There has been a great deal of publicity about “*the great reset*” following the COVID-19 pandemic, and many politicians in western countries seem to be promoting and coordinating this narrative. However, the reality for everyday citizens has been anything but positive, and there are indicators that matters will get much worse. According to Glenn Beck, in his new book entitled “*The Great Reset: Joe Biden and the Rise of Twenty-First-Century Fascism*”.

“An international conspiracy between powerful bankers, business leaders, and government officials; closed-door meetings in the Swiss Alps; and calls for a radical transformation of every society on earth – the Great Reset sounds like it is “one henchman with an eye-patch” away from being the plot for the next James Bond movie. But the Great Reset is not a work of fiction. It is a highly influential movement among the world’s elite to “reset” the global economy using banks, government programs, and environmental, social, and governance metrics. If they are successful and the Great Reset is finalized, it would put substantially more economic and social power in the hands of large corporations, international institutions, banks, and government officials, including Joe Biden, the United Nations, and many of the members of the World Economic Forum.”

So far, this “*reset*” has produced the highest inflation in many decades, which decreases the value of wages and pillages savings and other assets. Central to this has been printing more money, creating more government programs and hand-outs, increasing regulations and taxes

that hamper business development, attacking the fossil fuel industry with a religious fervor that has made it necessary to import oil from foreign countries and adversaries. Also, removing national borders so that millions of illegal immigrants can have all their expenses funded by taxpayers (without permission from these taxpayers). To exacerbate matters further, lawlessness has increased exponentially within these same western countries over a short period of time, and school children are part of an indoctrination process many times worse than anything devised to create the Hitler Youth.

In truth, “*the great reset*” is a subterfuge emanating from “*the god of this age*” who is more than capable of deceiving **the entirety of mankind, “whose minds the god of this age (Satan) has blinded”**(cf. 2Cor. 4:4a).

Now the serpent (metaphor describing Satan; cf. Rev. 12:9) *was more cunning* (in a negative sense) *than any beast* (living being) *which the Lord God had made...* (Gen. 3:1a; NKJV used throughout unless otherwise noted; Ed. notes in parentheses).

Therefore, the majority of mankind is completely unaware that Satan is influencing those behind this great reset agenda. The main reason for this “*great deception*” is that mankind’s mortal enemy needs to have centralized power as opposed to independent countries and/or states. His ultimate goal is to have everyone, everywhere, embracing and following his lawless agenda. Eventually he will succeed, even though it will only be for a short period of time (cf. Rev. 12:12; 17:12). This is confirmed by the Bible’s figurative language that describes a group of independent nation-states that finally agree to exchange their sovereignty for some yet-to-be-revealed benefit. Or it may be a global system of

government that grants power to various "unelected leaders" in organizations like the WHO, WEF, WTO, IMF, ISO, IAEA, ICJ, etc., thus usurping the authority of governments that were elected by their citizens. The time of this future scenario is linked to the return of Jesus Christ who will introduce "his Father's reset" that will actually be "the greatest reset" in man's history.

*And the ten horns which you (John) saw are ten kings who have received no kingdom as yet, but **they receive authority for one hour as kings with the beast.** ¹³These are of one mind, and they will give their power and authority to the beast (centralized worldwide system of government). ¹⁴These will make war with the Lamb (symbol representing Christ), and the Lamb will overcome them, for he is Lord of lords and King of kings; and those who are with him are called, chosen, and faithful (Rev. 17:12-14; Ed. notes in parentheses; emphasis added).*

So, there is a direct link between the formation of a worldwide system of government, and the return of Jesus Christ. Why? Because the old adage applies, "absolute power corrupts absolutely". Therefore, Christ will have to intervene just before this completely corrupt and lawless global government utterly destroys the planet.

And unless those days were shortened, no flesh would be saved; but for the elect's sake those days will be shortened (Mt. 24:22).

Central to Christ subjugating this universal government system will be restraining the real power behind it.

Then I (John) saw an angel coming down from heaven, having the key to the bottomless pit and a great chain in his hand. ²He laid hold of the dragon, that serpent

of old, who is the Devil and Satan, and bound him for a thousand years; ³and he cast him into the bottomless pit, and shut him up, and set a seal on him, so that he should deceive the nations no more till the thousand years were finished. But after these things he must be released for a little while (Rev. 20:103; Ed. note in parenthesis; emphasis added).

It will take a thousand years to rebuild everything and reeducate everyone who survives "the great tribulation", which is mentioned in Matthew 24:21 and Revelation 7:14. Also, this extended period of time will allow everyone to enjoy and experience all the benefits associated with obeying God's law and commandments. However, some scriptures imply that not everyone who survives into this millennium will immediately embrace this totally different way of living because it will include observing God's appointed Holy Days.

*And it shall come to pass that everyone who is left of **all the nations** which came against Jerusalem **shall go up from year to year to worship the King, the Lord of hosts, and to keep the Feast of Tabernacles** (cf. Dt. 31:9-13). ¹⁷And it shall be that **whichever of the families of the earth do not come up to Jerusalem to worship the King, the Lord of hosts, on them there will be no rain** (famine) (Zech. 14:16-17; Ed. notes in parentheses; emphasis added).*

There are numerous reasons that this future scenario will be "the greatest reset in history", and some of these will be examined in order to draw a comparison between the way we live today, and how much better God's way of living will be

He (Christ) shall judge between nations (cf. Jn. 5:22) and shall rebuke many people; they

*shall beat their swords into plowshares, and their spears into pruning hooks; **nation shall not lift up sword against nation, neither shall they learn war anymore*** (Isa. 2:4; Ed. notes in parentheses; emphasis added).

The moment a country's border is breached, the perpetrators will be stopped and punished accordingly.

Cursed is the one who moves his neighbor's landmark.... (Dt. 27:17a; cf. 19:14; Prov. 22:28; 23:10)

Therefore, there will be no loss of life related to warfare. Hence, no grieving parents, no widows, no fatherless children, and no decimation of economies. Also, the money usually earmarked for military expenditures will be used for more productive endeavors. The following statistics are from an article entitled: "The Cost of U.S. Wars Then and Now" by Norwich University Online; October 20, 2020.

World War 1 – Cost was \$ 334B, which was 14.1% of GDP, with 4.7M military personnel deployed; 116,516 deaths, and 204,002 wounded in action.

World War II – Cost was \$ 4.1T, which was 37.5% of GDP, with 12.2M military personnel deployed; 418,500 civilian and military deaths.

Numerous armed conflicts between 2001 – 2014 – Cost has been \$1.5- 1.7T, which represents 4.3% of GDP, with 2.5M military personnel deployed; 6,852 deaths, and 52,010 wounded in action.

So, from the onset of World War 1 until 2014, the U.S.A. has spent in excess of \$ 6.1T. This does not account for the billions spent by other countries during the same period of time. With no wars occurring for a thousand years under

Christ's leadership, the amount of money being redirected to more important projects will have an incredibly positive effect on all the nations of this world.

What about the cost of crime, especially in societies that adopt weak or ineffective deterrents? The following excerpt is from the U.S. Government Accountability Office.

Burglary, murder, identity theft – all crimes have costs for victims and society. The Department of Justice reported that federal, state, and local governments spent more than \$280B in 2012 on criminal justice, including police protection, the court system, and prisons. However, there are many other costs that researchers consider when estimating the total cost of crime in the United States. These can include tangible costs like replacing damaged property, and intangible costs like victims' pain and suffering (compensation often paid by taxpayers money). Researchers have estimated varying annual costs of crime in the United States can range from \$690B to \$3.41T

(<https://www.gao.gov/blog/2017/11/29/how-much-does-crime-cost>; Ed. note in parenthesis).

Again, these huge expenditures could be significantly reduced if there was a system of justice that rewarded good behavior and punished harmful actions. One overriding principle in God's legal system is restitution as opposed to handling every offense by putting people in jail; the cost of which punishes law-abiding taxpayers because they are "footing the bill".

If a man steals an ox or a sheep, and slaughters it or sells it, he shall restore five oxen for an ox and four sheep for a sheep (Ex. 22:1; emphasis added).

If the theft is certainly found alive in his hand, whether it is an ox or donkey or sheep, he shall restore double (Ex. 22:4; emphasis added).

The crime of premeditated murder is supposed to carry the death penalty because every life comes from Almighty God and only, He has the right to remove it. Unfortunately, many so-called authorities in man's world accuse God of being unfair, unreasonable, or cruel when it comes to the death penalty. The consequence of this self-righteousness is that the spouses, children, and other family members of murder victims suffer emotionally and often financially; and murder rates escalate because leniency sends a message that the victim's life is of less value than the criminal's. In addition, when a murderer goes to prison, taxpayers end up paying this cost which is substantial.

But if anyone hates his neighbor, lies in wait for him, rises against him and strikes him mortally, so that he dies, and he flees to one of these cities (of refuge; cf. Dt. 19:1-10),¹² then the elders of his city shall send and bring him from there (extradite him), and deliver him over to the hand of the avenger of blood (following due process; cf. Dt. 17:6).¹³ Your eye shall not pity him, but you shall put away the guilt of innocent blood from Israel, that it may go well with you (and your nation as a whole) (Dt. 19:11-13; cf. Gen. 9:6; Lev. 24:17; Ed. notes in parentheses).

Also, anyone caught kidnapping, or raping will face the death penalty (Dt. 24:7; 22:25).

Therefore, Christ's one-thousand-year reign will be a time of peace and prosperity; the like of which this planet has never known. It will be surreal for those who survive into it. To illustrate other major changes, a list of scriptures follows. Bear in mind, this is not

exhaustive or representative of everything that will be done:

The central, or federal, tax rate will be 10%; and everyone will pay it regardless of income (cf. Lev. 27:30, 32; Dt. 14:22).

This 10%, or tithe, will be administered by God's future priesthood who will be responsible for legal matters, health and safety matters, financial administration; plus religious activities and instruction (cf. Nu. 18:26; Dt. 16:18-19; 1Chron. 25-26; Isa. 66:18-24).

All debts will expire at the end of each and every seven-year cycle (Dt. 15:1-2). And, instead of waiting to retire in one's senior years (under Satan's system), everyone will have this seventh year off work to pursue other interests, or simply relax and enjoy life (Lev. 25:1-7). Therefore, anyone living to the age of seventy, will have experienced "approximately" ten Sabbatical years within their lifetime.

Because this millennial period of time will be under the supervision of Jesus Christ, and everyone will be following the same law and commandments (Isa. 2:3; Hab. 2:14), no one will pay interest on borrowed money (Gal. 3:28 cf. Because it is such an important issue, the resurrected Elijah will be in charge of overseeing the program and making sure it is successful because the continued survival of mankind depends upon it (Mal. 4:5-6).

Everyone will be given a piece of land on which to build, and it cannot be removed from them

except for a period of time if they decide to lease it out, or if they fall into debt. In the latter scenario, the land will return to them if someone acts to restore it, or when the Year of Jubilee comes around (Lev. 25:8-17).

These are only a few more changes that will occur following Christ's return but, in a "*nutshell*", everything that Satan has built up over thousands of years will be torn down and replaced with systems aligned with the law and commandments of Almighty God.
